## MR STEVE COLLIER - ROSZARKE ENGLISH SETTERS (BITCHES)

Having been introduced to the world of dog showing in the mid 1970's, Maureen and I purchased our first English Setter in 1978, which was the start of our successful Roszarke English Setter kennel. Over the years we have bred / owned 9 Show Champions, numerous CC winners and one of the breed's top stud dogs. I first started judging at Open Shows in 1983 and went on to award CC's in English Setters for the first time at WELKS in 1993 and to date have awarded CC's at 14 shows, including Crufts in 2009. Other judging experience includes awarding CC's in Australia in 2003 and 2019, plus numerous other gundog breeds, groups and BIS's at open shows around the UK.

I have been actively involved in all aspects of show management, from being an officer of local canine societies, to serving over 30 years on the Northern English Setter Society, Secretary of the English Setter Joint Judges Committee, the original Breed Education Coordinator for English Setters, Kennel Club Breed Liaison representative / gundog delegate and a member of the Kennel Club.

## SPECIAL AWARDS - JUDGE MRS VERA LYONS (MIRRLEES)

I grew up with pat dogs at home and more with my Dads family, also working border collies which I had the joy of working and bringing in the cows for milking. Love dogs and it will be a sad day when I have no more.

## REFEREE: MRS JANE BISHOP (DYRHAM)

We acquired our first English Setter in 1983, at the time we were warned they can become very collectable, how true this was. In 1984 Sorrel (Cornwood Northern Classic) joined the family and became my constant companion around the shows. As our brood increased we decided that we would like to have a litter and after several attempts the first Dyrham litter arrived in 1992 and so it went on from there. I enjoy both judging and showing and have achieved success at both Open and Champion Shows, one of the highlights being Jasper (Dyrham Desert Storm) gaining his title. Since 1994 I have been a member of the SESS committee and my local ring craft club and take pleasure from being able to contribute something back to the dog world. ## RULES AND REGULATIONS

- 1 The Show will open at 9.30 a.m.
- 2 Dogs will be received until 12 noon and after which no dogs may be received except under exceptional and unforeseen circumstances and by special permission of the Show Management
- 3 Bitch Judging will commence at 10.30 a.m. and Dogs at 10.45 a.m.
- 4 UNBENCHED SHOW Exhibits may be removed from the Show after their judging has been completed. The Show will close half an hour after all judging has been completed.
- 5 ENTRY FEES:

£15.50 per Class (MEMBERS); Subsequent Classes £4.00 £18.00 per Class (NON-MEMBERS); Subsequent Classes £4.00 Not for Competition £4.00. Membership £6.00 Single, Joint £7.50 ONLINE at <a href="https://www.onlineshowentry.com">www.onlineshowentry.com</a> close SUNDAY 26 OCTOBER 2025 midnight

- 6 No prize money is on offer at this show: except special classes
- 7 The Committee reserves to itself the right to refuse entries.
- 8 Puppies under four calendar months of age on the day of the Show are not eligible for exhibition.
- 9 The mating of bitches within the precincts of the Show is forbidden.

## 10 Best Puppy in Show.

Where a Best Puppy in Show competition is scheduled the Best Puppy in Show is a puppy which has competed and is unbeaten by any other puppy exhibited at the same show. A puppy is a dog of six and not exceeding twelve calendar months of age on the first day of the Show. The selection of Best in Show may follow the selection of Best Puppy in Show and Best Veteran in Show (if scheduled) respectively. Where the Best in Show is a puppy it may, at the discretion of the judge, be awarded Best Puppy in Show. Where the Reserve Best in Show is a puppy which has only been beaten by an adult dog it may, at the discretion of the judge, be Best Puppy in Show.

A Baby Puppy is a dog of four and less than six calendar months of age on the first day of the show. Baby Puppy classes may be scheduled at any breed club show. Any Variety Baby

## 11 Best in Show

Best in Show must be selected from the exhibits declared Best of Sex

If a Reserve Best in Show is to be selected, the eligible dogs are those

declared Best Opposite Sex and Reserve Best of Sex to the exhibit declared Best in Show.

- 12 Exhibits will not be admitted to Best in Show competition after a period of ten minutes has elapsed since the announcement that exhibits are required for judging, unless they have been unavoidably delayed by previous judging not completed on time, and then only with the special permission of the Show Management.
- 13 Exhibitors must not pick up dogs by their tails and leads when lifting them nor handle a dog in a manner which causes its feet not touch the ground when on the move. This is not acceptable. Exhibitors should note that such practice would constitute harsh handling and reports of such practice will be referred to the Committee under Kennel Club Show Regulation F11.
- All exhibitors must be familiar with Kennel Club Regulation F (Annex B) -Regulations for the Preparation of Dogs for Exhibition.

- All dogs resident outside the UK must be issued with a Kennel Club Authority to Compete number before entry to the show/event can be made. All overseas entries without an Authority to Compete number will be returned to the exhibitor/competitor.
- DOGS IN VEHICLES ON HOT DAYS Your dog is vulnerable and at risk during hot weather and the Kennel club offers the following guidance to help guide you through the do's and don'ts travelling to and whilst at KC licensed events.
- When travelling to a show please take a moment to consider whether the route to the show is on a busy holiday route, and leave earlier to avoid
- increased time in traffic jams.
  - If your vehicle is not air-conditioned seriously consider whether travelling
- to the show is a good idea at all.
- The vehicle should be as fully ventilated as possible, and plenty of stops
- should be taken, with lots of water available to drink.
- Ensure your dog is not sitting in full sunlight. There should be plenty of
- free flowing air around the dog

When at the show, never leave your dog in the vehicle.

Keep the dog in the shade - take your own shade for example a large umbrella and always have plenty of water available to drink so your dog stays well hydrated.

Avoid your dog taking part in unnecessary exertion, or from standing in exposed sunlight for extended lengths of time.

Remember, if you feel hot your dog is very likely to feel much hotter and dehydrated, and this could lead to dire results. Please look after your dog's welfare

Anyone whose dog is entered at a Kennel Club licensed event should take all reasonable steps to ensure the needs of their dog(s) are met, and should not put a dog's health and welfare at risk by any action, default, omission or otherwise. Breach of Kennel Club Regulations in this respect may be referred to the Board for disciplinary action under the Kennel Club Rules and Regulations. The use of pinch collars, electronic shock collars, or prong collars, is not permitted at any show licensed by the Kennel Club. This shall apply at the venue or within the precincts of the show.

## 18 Not for Competition.

Not for Competition entries will be accepted. Details of each dog so entered must be recorded on the entry form and must be Kennel Club registered

- No modifications will be made to the schedule except by permission of the Board of the Kennel Club, which will be followed by advertisement in the Canine Press wherever possible.
- 20 An exhibitor or competitor should ensure that contact details for any handler are available and must be provided upon request in any investigation of a breach of this regulation by such handler.

## **EXERCISE AREA**

An Exercise Area will be provided

Exhibitors/Handlers are required to clear up any fouling by the dog(s) in their charge.

### Additional Rules and Regulations

- i Should any judge be prevented from fulfilling their engagement, the Committee reserves to themselves the right of appointing other judges to fulfil their duties. Exhibitors are at liberty to withdraw from competition but no entry fees can be refunded.
- Any owner, competitor or other person in charge of a dog is required to remove as soon as possible any fouling caused by their dog(s) at any Kennel Club licensed venue and within the environs of that event including car and caravan parks and approaches. Adequate receptacles for the disposal of such fouling will be provided.
- The Committee will do its utmost to ensure the safety of the dogs brought for exhibition but it must be clearly understood by exhibitors and all other persons at the Show that the Committee will not be responsible for the loss or damage to any dogs or property, or personal injury whether arising from accident or any other cause whatsoever.
- iv An announcement prior to the date of closing of entries in Our Dogs of any alteration or addition made by the Committee to the schedule or in these Rules shall be sufficient notice thereof.
- v All children must be kept under control and parents will be held responsible for any damage caused and charges incurred.

## DEFINITIONS OF CLASSES

(the word "dog" includes both sexes) In the following Definitions, a Challenge Certificate includes any Show award that counts towards the title of Champion under the Rules of any governing body recognised by the Kennel Club

Wins at Championship Shows in Breed classes where Challenge Certificates are not on offer shall be counted as wins at Open Shows.

In the case of a dog owned in partnership and entered in Members' classes or competing for Members' Specials each partner must at the time of entry be a member of the Society

In estimating the number of awards won, all wins up to and including the seventh day before the date of closing of entries shall be counted when entering for any class, i.e. Sunday 17th OCTOBER 2025.

Wins in Variety classes do not count for entry in Breed classes but when entering for Variety classes, wins in both Breed and Variety classes must be counted.

A First Prize does not include a Special Prize of whatever value.

If an exhibitor reports before the judging of a class or classes that a dog has been entered which is ineligible, the exhibitor may choose one of the following options:-

#### (1) WITHDRAWAL

The dog may be withdrawn from competition subject to the conditions of Regulations F.(1).19.20.

### (2) TRANSFER

- a) If a dog is ineligible for a class or classes as regards its breed, colour, sex, weight or height the Show Secretary shall transfer it to the equivalent class or classes for the correct breed, colour, sex, weight or height and, in the event of there being no equivalent class. Minor Puppy and Puppy excepted, to the Open class for the correct breed, colour, sex, weight or height.
- b) If an exhibit entered incorrectly in a Minor Puppy class, Puppy class or Junior class, which is over age but under 12 calendar months of age, 18 calendar months of age or 24 calendar months of age respectively, the Show Secretary shall transfer the exhibit to the Puppy class. Junior class or Yearling class respectively for the correct breed, colour, sex, weight or height and in the event of there being no Puppy class, Junior class or Yearling class, to the Open class for the correct breed, colour, sex, weight or height
- c) For any reason other than the above, the Show Secretary shall transfer it to the Open class for the correct breed, colour, sex, weight or height.
- d) If an exhibit arrives late and misses a class, even if it is the only class in which the dog is entered, the dog may not be transferred to any other class.

#### MINOR PUPPY

For dogs of six and not exceeding nine calendar months of age on the day of the Show

#### PUPPY

For dogs of six and not exceeding twelve calendar months of age on the day of the Show

#### JUNIOR

For dogs of twelve and not exceeding twenty-four calendar months of age on the first day of the Show.

#### YEARLING

For dogs of twelve and not exceeding twenty-four calendar months of age on the first day of the Show.

#### SPECIAL YEARLING

For dogs of six and not exceeding twenty-four calendar months of age on the first day of the Show.

#### NOVICE

For dogs which have not won a Challenge Certificate/CACIB/CAC/Green Star or three or more First Prizes at Open and Championship Shows (Minor Puppy, Special Minor Puppy, Puppy and Special Puppy classes excepted, whether restricted or not).

#### GRADUATE

For dogs which have not won a Challenge Certificate/CACIB/CAC/Green Star or four or more First Prizes at Championship Shows in Graduate, Post Graduate, Minor Limit, Mid Limit, Limit and Open classes, whether restricted or not where Challenge Certificates were offered for the breed.

#### **POST GRADUATE:**

For dogs which have not won a Challenge Certificate/CACIB/CAC/Green Star or five or more First Prizes at Championship Shows in Post Graduate, Minor Limit, Mid Limit, Limit and Open classes, whether restricted or not where Challenge Certificates were offered for the breed.

#### LIMIT

For dogs which have not become show Champions under the Kennel Club Regulations or under the rules of any governing body recognised by the Kennel Club, or won 3 or more CC/CACIB/CAC/Green Stars or won 7 or more First Prizes in all at Championship Shows in Limit or Open Classes confined to the Breed, whether restricted or not at Shows where Challenge Certificates were offered for the breed.

#### OPEN

For all dogs of the breeds for which the class is provided and eligible for entry at the Show.

#### VETERAN:

For dogs of not less than seven years of age on the day of the Show

#### **BEST VETERAN IN SHOW**

For wining dogs of Veteran Classes only.

#### SPECIAL BEGINNERS

For owner, handler or exhibit not having won a Challenge Certificate.

#### SUNTOP MEMORIAL AWARD(S).

Open to all Dogs and Bitches of the breed having entered a scheduled breed class and eligible for entry at the show

## REGULATIONS FOR THE PREPARATION OF DOGS FOR EXHIBITION F(B)

- These Regulations must be observed when a dog is prepared for exhibition and/or exhibited at any Kennel Club Licensed event. Objections may be referred to the General Committee for disciplinary action under these Show Regulations and/or for disciplinary action under Kennel Club Rule All.
- (a) A dog found to have been exhibited in breach of these Regulations will automatically be disqualified from exhibition at the show and from any award gained thereat.
- (b) Unless the exhibitor provides a satisfactory explanation for the dog being exhibited in breach of these Regulations then he/she may be subject to further penalties of either a fine or as listed under Rule All.
- 2.(a) No substance which alters the natural colour, texture or body of the coat may be present in the dog's coat for any purpose at any time during the show. No substance which alters the natural colour of any external part of the dog may be present on the dog for any purpose at any time during the show.
  - (b) Any other substance (other than water) which may be used in the preparation of a dog for exhibition must not be allowed to remain in the coat or on any other part of the dog at the time of exhibition.
- No act or operation which alters the natural conformation of a dog or any part thereof may be performed except:-
- (a) Operations certified to the satisfaction of the General Committee
- (b) The removal of dewclaws of any breed
- (c) Operations to prevent breeding provided that such operations are notified to the Kennel Club before neutered dogs are shown. Nor must anything be done calculated in the opinion of the General Committee to deceive.
- 4. The General Committee without previous notice may order an examination of any dog at any Show. Any examination thus ordered will be made by a person having executive authority who shall have a written directive from the Kennel Club in their possession. Samples may be taken for further examination and analysis.
- 5. An individual has the right to lodge an objection to a dog only if he/she is the owner or handler of a dog competing in the same breed or class. An objection may however, be lodged by an official of the Show or by anyone so deputed by the Kennel Club. It will be the responsibility of the individual who lodges the objection or the official (as appropriate) to substantiate the grounds for the objection. The Kennel Club will substantiate the grounds for an objection made on its behalf.
- Any objection by an individual related to an infringement of these Regulations must be made in writing to the Show Secretary at his/her office before the close of the Show and the individual must produce evidence of identity at the time of lodging the complaint.

#### IMPORTANT INFORMATION FOR ALL DOG SHOW EXHIBITORS

The General Committee of the Kennel Club has approved a recommendation which requires exhibitors to display the exhibit/bench number on their crate, cage or container at all times. This is particularly important when cages etc are not on benches, and at un-benched shows.

Each exhibitor is responsible for providing their own crate or cage identification and should note that the original exhibit/bench number card, as provided by the show society, must not be used for this purpose.

## REGULATIONS FOR THE PREPARATION OF DOGS FOR EXHIBITION F(B)

- These Regulations must be observed when a dog is prepared for exhibition and/or exhibited at any Kennel Club licensed event. Objections may be referred to the General Committee for disciplinary action under these Show Regulations and/or for disciplinary action under Kennel Club Rule A42
- (a) A dog found to have been exhibited in breach of these Regulations will automatically be disqualified from exhibition at the show and from any award gained thereat.
- (b) Unless the exhibitor provides a satisfactory explanation for the dog being exhibited in breach of these Regulations then he/she may be subject to further penalties of either a fine or as listed under Rule A42.
- 2.(a) No substance which alters the natural colour, texture or body of the coat may be present in the dog's coat for any purpose at any time during the show. No substance which alters the natural colour of any external part of the dog may be present on the dog for any purpose at any time during the show,
- (c) Any other substance (other than water) which may be used in the preparation of a dog for exhibition must not be allowed to remain in the coat or on any other part of the dog at the time of exhibition.
- 3 No act or operation which alters the natural conformation of a dog or any part Thereof may be performed except:-
- (a) Operations certified to the satisfaction of the General Committee
- (b) The removal of dewclaws of any breed
- (b) Operations to prevent breeding provided that such operations are notified to the Kennel Club before neutered dogs are shown. Nor must anything be done calculated in the opinion of the General Committee to deceive.
- The General Committee without previous notice may order an examination of any dog at any Show. Any examination thus ordered will be made by a person having executive authority who shall have a written directive from the Kennel Club in their possession. Samples may be taken for futher examination and analysis
- An individual has the right to lodge an objection to a dog only if he/she is the owner or handler of a dog competing in the same breed or class. An objection may however, be lodged by an official of the Show or by anyone so deputed by the Kennel Club. It will be the responsibility of the individual who lodges the objection or the official (as appropriate) to substantiate the grounds for the objection The Kennel Club will substantiate the grounds for an objection made on its behalf.
- 6 Any objection by an individual related to an infringement of these Regulations must be made in writing to the Show Secretary at his/her office before the close of the Show and the individual must produce evidence of identity at the time of lodging the complaint.
